All OHB employees and contractors will adopt the Corporate Social Responsibility considerations described in this policy into their day-to-day work activities. OHB leaders will act as role models by incorporating those considerations into decision-making in all business activities. OHB's leaders will ensure that appropriate organizational structures are in place to effectively identify, monitor, and manage Corporate Social Responsibility issues and performance relevant to our businesses.

This Policy is built on the following areas that reflect existing and emerging standards of Corporate Social Responsibility:

## Business Ethics and Transparency

OHB will advise our partners, contractors, and suppliers of our Corporate Social Responsibility Policy, and will work with them to achieve consistency with this policy.

OHB is committed to measuring, auditing and publicly reporting performance on its Corporate Social Responsibility programs.

OHB will integrate Community Investment considerations into decision-making and

business practices, and will assist in local capacity building to develop mutually beneficial relationships with communities.

OHB will contribute to our host communities' quality of life by supporting innovative programs in health, education, social services and the environment, as well as cultural and civic projects.

OHB will strive to provide employment and economic opportunities in the communities where we operate.

OHB is committed to providing equal opportunity in all aspects of employment and will not engage in or tolerate unlawful workplace conduct, including discrimination, intimidation, or harassment.
